BACKGROUND: In 2001, the 77th Legislature amended the Health and Safety Code to

create the Texas Drug Donation Program. The program creates a

mechanism to allow unused prescription drugs to be donated to charitable medical clinics and redistributed, under the supervision of a licensed

pharmacist, to financially disadvantaged patients.

DIGEST: CSHB 3078 would expand the Texas Drug Donation Program to allow

pharmacists in penal institutions to return to a pharmacy unused drugs still in their original packaging. The bill also would provide that a community pharmaceutical access program provider, defined as a licensed pharmacy

program that assists financially disadvantaged persons to access

prescription drugs at no charge or a reduced price, would be authorized to

receive donated drugs.

The bill would take immediate effect if finally passed by a two-thirds record vote of the membership of each house. Otherwise, it would take effect September 1, 2007.

SUPPORTERS SAY:

CSHB 3078 would allow more useful drugs to be used for medical care and decrease some of the cost for providing healthcare and drugs for the financially indigent by allowing pharmacists in penal institutions to participate in the program. At a time when care for the indigent is stretched, the bill would provide a new channel for providing lower cost healthcare and access to prescription drugs.

OPPONENTS SAY:

No apparent opposition.
