BACKGROUND: Under Education Code, sec. 39.306, a school board is required to publish

an annual report describing the educational performance of the district and of each campus in the district that includes uniform student performance

and descriptive information.

Education Code, sec. 42.006 governs the Public Education Information Management System (PEIMS), through which each school district and open-enrollment charter school is required to provide certain data, including useful, accurate, and timely information on student demographics and academic performance, personnel, and school district finances.

Concerned parties suggest PEIMS could provide more helpful information if the system collected more detailed information on school counselors.

DIGEST:

SB 490 would require the Commissioner of Education, by rule, to have each school district and open-enrollment charter school report through the Public Education Information Management System (PEIMS) information regarding the availability of school counselors at each campus. A school district or school would be required to report the number of full-time equivalent school counselors providing counseling services at a campus. The Texas Education Agency would maintain the information provided in accordance with this subsection.

The bill also would require the number of school counselors providing counseling services at each school to be included in the annual performance report required of each school district.

The bill would take immediate effect if finally passed by a two-thirds record vote of the membership of each house. Otherwise, it would take effect September 1, 2017.
