**BACKGROUND:** 

Under Education Code sec. 37.0815, a school district or open-enrollment charter school may not prohibit a person, including a school employee, who holds a license to carry a handgun from transporting or storing a handgun or other firearm or ammunition in a locked, privately owned or leased motor vehicle in a district or school parking area provided that the handgun, firearm, or ammunition is not in plain view.

This does not authorize a person to possess, transport, or store a handgun, a firearm, or ammunition in violation of other law.

Some have suggested that schools are implementing additional regulations for the storage of concealed handguns and ammunition in locked vehicles.

DIGEST:

HB 1143 would prohibit a school district or open-enrollment charter school from regulating the manner in which a handgun, firearm, or ammunition that was not in plain view was stored in a vehicle in a parking area as authorized under Education Code sec. 37.0815.

The bill would apply beginning with the 2019-2020 school year.

This bill would take immediate effect if finally passed by a two-thirds record vote of the membership of each house. Otherwise, it would take effect September 1, 2019.
