BACKGROUND:

Labor Code sec. 504.019(a)(2) defines post-traumatic stress disorder as a disorder that meets diagnostic criteria specified by the American Psychiatric Association in the Diagnostic and Statistical Manual of Mental

Disorders, fifth edition, or a later edition adopted by the commissioner of workers' compensation.

Under sec. 504.019(b), PTSD is a compensable injury under the workers' compensation system for a first responder employed by a political subdivision of the state, including peace officers, firefighters, and emergency medical services personnel, if it was based on a diagnosis that:

- the disorder is caused by an event occurring in the course and scope of the first responder's employment; and
- the preponderance of the evidence indicates that the event was a substantial contributing factor of the disorder.

Concerns have been raised that this section requires a diagnosis that the disorder relates to a single event, although some note that the disorder can be caused by multiple events.

DIGEST:

CSHB 2143 would specify that post-traumatic stress disorder (PTSD) suffered by a first responder would be a compensable injury under the state's workers' compensation system if it was based on a diagnosis that:

- the disorder was caused by one or more events occurring in the course and scope of the first responder's employment; and
- the preponderance of evidence indicated that the event or events were a substantial contributing factor of the disorder.

The bill would take effect September 1, 2019, and would apply to a claim for workers' compensation benefits based on a compensable injury that occurred on or after that date.
