BACKGROUND:

Some have noted that potentially preventable maternal deaths can occur after 60 days postpartum, at which point women who were eligible for Medicaid coverage are no longer required to be covered under federal law.

DIGEST:

HB 744 would require the Health and Human Services Commission (HHSC) to continue to provide health benefits to women who were eligible for medical assistance for pregnant women for at least 12 months following a delivery or involuntary miscarriage.

If a state agency determined that a waiver or authorization from a federal agency was necessary to implement a provision of the bill, the agency would be required to request the waiver and would be permitted to delay implementation of the provision until the waiver or authorization was granted.

The bill would take effect September 1, 2019.

NOTES:

According to the Legislative Budget Board, the bill would have a negative impact of about \$75 million to general revenue related funds through
