BACKGROUND:

Education Code ch. 38, subch. G requires the Texas Education Agency and Health and Human Services Commission to provide programs and practices for mental health and substance abuse prevention and intervention, and suicide prevention.

Concerned parties have noted that during the pandemic some students have felt isolated due to limited access to their peers and support networks. Some have called for the state to raise awareness and promote mental health services available to students.

DIGEST:

HB 1754 would require that all student identification cards issued by a public school to a student in grade six or higher include contact information for the National Suicide Prevention Lifeline.

The provisions of this bill would apply beginning with student identification cards issued for the 2022-2023 school year.

The bill would take immediate effect if finally passed by a two-thirds record vote of the membership of each house. Otherwise, it would take effect September 1, 2021.
