Interested parties have called for better support for educators and students following natural disasters and traumatic events.

DIGEST: CSHB 4257 would require a district to include in its trauma-informed care policy a plan for providing support to students, teachers, and district staff in the event of a crisis, including through methods such as psychological first aid and referrals to district mental health professionals, if available, and community providers for mental health services.

The bill's provisions would apply beginning with the 2021-2022 school year.

The bill would take immediate effect if finally passed by a two-thirds record vote of the membership of each house. Otherwise, it would take effect September 1, 2021.
