DIGEST

Currently, the Election Code uses mostly masculine pronouns and other language that is gender specific. Some Texas codes, including the Banking Code and Credit Code, have been rewritten to conform to the mandates of gender neutral language. This bill makes no substantive changes to the Election Code; however, the bill changes gender specific language to language that is gender neutral.

PURPOSE

As proposed, H.B. 1603 changes gender specific language in the Election Code to language that is gender neutral.

RULEMAKING AUTHORITY

This bill does not grant any additional rulemaking authority to a state officer, institution, or agency.
