DIGEST

Water control and improvement districts are districts created under the Texas Constitution to supply water and wastewater service, control stormwater, irrigate land, provide parks and recreational facilities, and accomplish other goals. S.B. 1822 would create the Horseshoe Bay Water Control and Improvement Districts No. 1, No. 2, and No. 3.

PURPOSE

As proposed, S.B. 1822 creates the Horseshoe Bay Water Control and Improvement District No. 1, No. 2, and No. 3.

RULEMAKING AUTHORITY

This bill does not grant any additional rulemaking authority to a state officer, institution, or agency.
