DIGEST AND PURPOSE

Certain persons have recognized that the creation of a water district to support the marketing of Lake Alan Henry water is necessary. As proposed, S.B. 1941 creates, administers, and provides powers, duties, operation and financing for the Lake Alan Henry Water District in Garza and Kent counties.

RULEMAKING AUTHORITY

This bill does not expressly grant any additional rulemaking authority to a state officer, institution, or agency.
