On November 7, 2017, voters will have a chance to consider seven constitutional amendments proposed by the 85th Legislature. The proposed amendments cover a wide range of topics, including property taxes, raffles, home equity loan provisions, and more.

The Texas Constitution is one of the longest in the nation, at an estimated 86,936 words (The Book of the States, vol. 49). The Constitution is changed through amendments, which are proposed by the Texas Legislature and accepted or rejected by the voters. Since the current Texas Constitution was adopted in 1876, 491 amendments have been passed.

Amendments Proposed for the November 7, 2017 ballot by the 85th Legislature

The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of part of the market value of the residence homestead of a partially disabled veteran or the surviving spouse of a partially disabled veteran if the residence homestead was donated to the disabled veteran by a charitable organization for less than the market value of the residence homestead and harmonizing certain related provisions of the Texas Constitution.

The constitutional amendment to establish a lower amount for expenses that can be charged to a borrower and removing certain financing expense limitations for a home equity loan, establishing certain authorized lenders

SJR Prop. to make a home equity loan, changing certain options for the refinancing of home equity loans, changing the threshold for an advance of a home equity line of credit, and allowing home equity loans on agricultural homesteads.

The constitutional amendment limiting the service of certain officeholders SJR Prop. appointed by the governor and confirmed by the senate after the 34 3 expiration of the person's term of office.

The constitutional amendment authorizing the legislature to require a court to provide notice to the attorney general of a challenge to the SJR Prop. constitutionality of a state statute and authorizing the legislature to 4 prescribe a waiting period before the court may enter a judgment holding the statute unconstitutional. The constitutional amendment authorizing the legislature to provide for an SJR Prop. exemption from ad valorem taxation of all or part of the market value of the residence homestead of the surviving spouse of a first responder who is killed or fatally injured in the line of duty. The constitutional amendment relating to legislative authority to permit HJR Prop. credit unions and other financial institutions to award prizes by lot to 37 7 promote savings.
