### MOTION TO RECESS AND ADJOURN

On motion of Senator Averitt and by unanimous consent, the Senate at 10:50 a.m. agreed to recess, upon conclusion of the Joint Session to canvass the votes, until 10:00 a.m. Tuesday, January 16, 2007, for the inauguration of the Governor and Lieutenant Governor.

The Senate further agreed to adjourn, upon conclusion of the Joint Session for the inauguration, until 11:00 a.m. Wednesday, January 17, 2007.

### AT EASE

The President at 10:50 a.m. announced the Senate would stand At Ease to proceed to the House of Representatives for the Joint Session to canvass the votes.

### JOINT SESSION

(To canvass votes cast for Governor and Lieutenant Governor at the General Election)

The Senators present, escorted by the Secretary of the Senate and the Sergeant-at-Arms, proceeded to the Hall of the House of Representatives at 11:00 a.m. to canvass the votes cast for the Governor and Lieutenant Governor at the last General Election.

Senator Janek, Chair of the Canvass Committee, was announced, and on invitation of the Speaker, occupied a seat on the Speaker's Rostrum.

The Senators were announced and were admitted and escorted to seats prepared for them along the aisle.

Senator Janek called the Senate to order and announced a quorum present.

The Honorable Tom Craddick, Speaker of the House of Representatives, called the House to order, stated the purpose of the Joint Session, and announced a quorum of the House present.

Speaker Craddick then announced the appointment of the Joint Committee of Tellers and requested the tellers appointed, pursuant to the provisions of **SCR 6**, to come forward and receive the returns of votes cast for Governor and Lieutenant Governor at the last General Election held on November 7, 2006, which returns had been duly delivered by the Secretary of State to the Speaker of the House of Representatives.

Senators Janek, Chair; Ellis, Fraser, Hinojosa, Nichols, and Watson on the part of the Senate, and Representatives Harper-Brown, Chair; Creighton, Harless, Hopson, Puente, and Quintanilla on the part of the House of Representatives, then received the returns and proceeded to count the votes cast for Governor and Lieutenant Governor at the last General Election.

Speaker Craddick at 11:19 a.m. announced that the Joint Session would stand At Ease awaiting the report of the Joint Committee of Tellers.

Speaker Craddick at 12:59 p.m. called the Joint Session to order.
